The project concluded on 31.12.2006.

CURRENT RESEARCH PROJECTS AND WORK IN PROGRESS

1 Global History in the Long Run

As Centennial Professor of Economic History, LSE and Convenor of a Network of 42 scholars who each and research in the field of global economic history, I supervised and organised a programmes of interdisciplinary seminars and conferences on Global History. The project, funded by the Leverhulme Trust, was networked with Research Centres and leading scholars involved in the development of global history in the Universities of California (Irvine and Los Angeles), Leiden, and Osaka, ended on ended on 31 December 2006.

I act as editorial director and coordinator for the publication of books based on papers presented at GEHN conferences. Three books of papers presented at GEHN conferences. These books remain on the agenda for publication: namely, Cultures of Enterprise in Europe and China; Imperialisms in Europe and China and Science and Technology in the Occident and Orient.

2 <u>Macro Inventors and Macro Inventions in British Textile Industries, 1688-1851</u>

This research project is designed to construct a prosopography of British inventors, 1688-1851; analyse their successes and failures in marketing their discoveries; and uses case studies to confront the prevailing historiography on the economic, intellectual, religious and institutional foundations of technical progress.
