## RESEARCH OVERVIEW

#### **BACKGROUND: BOOKS 1981 to 1988**

My major publications form a long-term project whose aim is to analyse modes of desire in a range of modern fictions. After a PhD thesis on a crisis of authorship represented by encounters with material objects in modernist texts by Proust, Rilke, Hofmannsthal and Sartre (published as *The Banal Object* in **1981**), I turned to the confessional *récit* of the 18c to 20c in *The Unintended Reader* (**1986**; **pb 2010**) and *Narcissus and Echo* (**1988**). The fictions by Prévost, Chateaubriand, Constant, Gautier, Mérimée, Musset, Nerval, Fromentin and Gide examined in these two books are confessional texts, tales told by a young man to an older man in which a woman is misloved and dies. Here authorship is a filial gesture and narrative is exchanged between men over the body of a woman. The figures of Narcissus and Echo, and their fates – to gaze or speak repetitiously – exemplify the masculine and feminine positions in these texts. A feminist reading, because it is unintended, may analyse the text's oedipal desire against the grain of its overt demand.

#### **BACKGROUND: BOOKS 1992 to 1998**

My second cross-language comparative-literary monograph is *The Adulteress's Child* (1992), a study of the relations of authorship and desire in 19c novels of adultery from France, Germany, Russia and America. The book examines seven novels by Stendhal, Flaubert, Tolstoy, Maupassant, Hawthorne and Fontane, seeking in key scenes and structures the politics of the implied author's paternal relation to male and female characters and to the

implied reader. One section looks at those texts — *Le Rouge et le noir, L'É ducation sentimentale, Anna Karenina* and *Pierre et Jean* — in which the beloved is the mother of sons: her husband is no serious rival, but her attachment to her son represents a different order of legitimacy. As the adulterous passion begins to develop, the child falls ill, provoking in the patrilinear mother a crisis of conscience and autonomy which the lover must try to exploit; whatever the outcome for him, the woman's capacity for desire is brought back into line by the control of authorial irony. The desire of the 'godlike author' is thus a version of *le nom/non du père*. A subsequent section turns to *Madame Bovary, Anna Karenina, The Scarlet Letter* and *Effi Briest*, in which the adulteresses are mothers of daughters — deemed fit, it seems, for no more iconic role than the shame of reproducing themselves. What emerges in this pairing of matrilinear women is the fixedness of a relation that can only be imagined by the paternal author as negative, marginal and repetitive. The Conclusion suggests how men's and women's relations to sameness and difference proceed in parenthood and authorship, and how the sublimations of patriarchy inevitably produce a culture of scarlet letters.

Continuing that interest, I coedited with Nicholas White a collection entitled *Scarlet Letters: Fictions of Adultery from Antiquity to the 1990s* (1997). The core of the book arose from a 1993 Conference at the Institute of Romance Studies exploring a number of issues in the 19c novel of adultery of Europe and America; further contributions look at triangular desire and its transgressive relation to different modes of legitimacy both in other historical periods and also in other genres such as popular film. My own contribution, apart from coediting, are two essays: a reworked piece on the adulteress's children and an article comparing triangular structures in the 1990s films *Fatal Attraction* and *The Piano*.

My second edited collection wholly concerned with questions of critical theory – the first being the coedited *Freud in Exile* (1988) – was *Coming Out of Feminism?* (1998), coedited with Mandy Merck and Elizabeth Wright. The aim of the collection was to explore how queer studies seem to have 'grown out' (in both senses) of feminism. In interestingly different ways, both the lesbian and the male gay movements originate in 1970s and 1980s feminism, but have developed theories of the fluidity of gender and sex identities which open up crucial questions for feminists and for women in general. As both an identity politics and a theory of knowledge, feminism has much to gain from this new debate and the generational issues it raises. I coauthored the Introduction and contributed an article on the problems of a feminist reading of pederastic desire in the work of Gide.

#### **RECENT BOOKS 1998 to 2009**

My monograph *André Gide: Pederasty and Pedagogy* (1998) developed from elements of *Narcissus and Echo* and *The Adulteress's Child*, and continued the investigation into masculinity in modern cultural production. Gide has come back into the fore in recent years with the rise of gay studies in Europe and the USA. In his apologia for pederasty, whether directly polemical or as a covert motive of the fiction, he is arguing for an exclusively self-referring form of the masculine; yet in a number of ways, his argument relies on the feminine, whether in women or in men, as the negative from which this value proceeds, and it leads most often towards failure or retreat – undesire.

The theoretical basis of the book's analysis takes up elements in the work of Didier Anzieu, Mary Douglas, Elizabeth Grosz and Thomas Laqueur, to develop a critical use of the hydraulic theory of desire as a system of interconvertible body fluids within and between bodies bounded by the 'psychic envelope' of the skin. In the introductory chapter, I apply this to theories of pedagogy and pederasty from the ancient world to the present. The next, biographical chapter explores Gide's life through his own and others' representations of his body. The subsequent five chapters build up a comparative examination of Gide's writings through a set of thematic issues: the woman's voice, the chain-formation of male structures, the fascination of 'the dangerous individual', the desire of uncles and aunts, and the pedagogic-pederastic motive of Gide's educational experimentation with animals and children.

The final chapter returns to theories of desire, the failure of the hydraulic metaphor, and explores some common elements between Gide, Carroll and Barrie.

Closely connected to this is the collection in French of the papers from my 1998 Conference *André Gide 1918*, entitled *Le Désir à l'œuvre: André Gide à Cambridge 1918, 1998* (2000, [2001]). My contributions, as well as sole-editing, are a chapter, 'Des oncles et des tantes', and the Introduction, 'Gide amoureux'.

Three years later I coedited an interdisciplinary collection which grew out of the MA I devised and directed at the University of Reading, *The Body & Representation*. *Indeterminate Bodies* (2003) brings together chapters on indeterminacy in the visual, performance and cinematic arts, textuality, law and history of science, with two sections of illustrations including series by two young British photographers. I wrote an article on Gide, Proust and Rose Macaulay, "Then some had rather it were *She* than *I*": sexing the textual body', and coauthored the introduction.

My most recent monograph is entitled *Consensuality: Didier Anzieu, gender and the sense of touch* (2009); it attracted a Leverhulme Trust Research Fellowship for the academic year 2003-04. The first section of the book, consisting of three chapters, introduces the work of Didier Anzieu (1923-1999), the son of Jacques Lacan's pseudonymous 'Aimée' and like her a replacement child, whose most influential work is *Le Moi-Peau* (1985, 1995) but whose psychoanalytic research and activity ranges more widely: the theory of psychic envelopes, studies of creativity and self-analysis (Freud, Borges, Beckett etc), psychodrama, the psychology of groups, fiction, cartoons, and a pseudonymous study of May 1968. My analysis both presents and criticises Anzieu's theories, particularly in relation to issues of gender, and proposes the potential of the skin-ego for a bodied psychoanalysis without castration. The key term 'consensuality' derives from Anzieu's theory of the eight functions of the skin-ego and in particular its capacity to cohere and connect the subject's senses; to this perspective I add the question of communication and consent between subjects through the sense of touch.

The second section of the book consists of a further six chapters. The first four of these carry the critical application of Anzieu's theories to a number of literary and cultural phenomena of the past two centuries, across three language fields (French, German and English) and three media (text, film and sculpture). Chapters 4 and 5 examine, respectively, the significance of the skin in two famous bodies, that of a homosexual man and that of a heterosexual woman, in each of which we can discern a gendered circuit of desire. André Gide's desire is a test case of the male body relating primarily to itself; I compare four aspects of Gide's relations to skin: itching, clothes, desire and pleasure – the latter as the emptying of the body-self to reach an ideal state of skin-and-bone. Princess Diana is analysed as the object, after death, of an obsessive focus on images of light and touch, radiance and bulimia; what these have in common is a structure wherein something circulates in and out; and that something, gazed-up at and gazed-down upon, is feminine beauty.

The next pair of chapters look at very different forms of the relation between a desiring or enquiring subject and its others. In Chapter 6, the other is, intrinsically at least, an ungendered object, a thing; what is the relation of the eye and the hand to a sculpted object? In Gautier's *Émaux et camées* and Rilke's essays on Rodin, the surface is all there is and desire is premised on the impossibility of penetration; how does this desire relate to the wish to turn sculpture to life (Pygmalion), render flesh into stone (Medusa) or animate a toy (Pinocchio)? Chapter 7 examines the phenomenon in 1990s cinema of the wish to desire 'through' the body of another: Flaubert deplored the necessity of 'getting into the skin' of characters; Gide longed to 'inhabit the skin' of an attractive man; in *Gattaca, The Talented Mr Ripley*, and *Being John Malkovich*, desire is both for and through the body of a more glamorous other.

The last two chapters return to a more general discussion of the relation of the psychic skin, desire and the possibility of consensuality to – in turn – love and loss. Beginning with imagery

of bodily desire, related to flight (zooming and hovering), in 19c and 20c poetry in French, chapter 8 goes on to compare theories of the caress in Merleau-Ponty, Sartre, Lévinas and Irigaray and to conclude that Anzieu, like Sartre, presents the desire of the subject as being the wish to be both the object of their object and the background against which that other's psychic world is measured. Chapter 9 closes with a reflection on loss and mourning, seeking to turn around the familiar psychoanalytic theory of loss as incorporation or introjection by focusing on the way that the lost object is carried, like the sibling of the replacement child, on or around the subject's skin-ego.

#### **CURRENT RESEARCH**

Eleven articles and chapters – on Gide, itching, translation, femicide, puppets and virtual touch – have appeared since 2017.

In 2016 I published my first book-length translation, Didier Anzieu's *The Skin-ego* [*Le Moi-peau*, 1995].

The coedited *On Replacement* appeared in 2018. A monograph on the same subject is in preparation, to be published by Brill in 2021.
